"To evaluate the AI search engine we gathered experts from different surgical specialties (general surgery, ear, nose and throat surgery, neurosurgery, orthopedics and trauma surgery and urology), IT experts and medical engineers to perform a systematic literature search on a specific scientific question in a predefined time frame. Participants were randomized to 3 different teams. All literature research was done in a one day event, with the 3 teams competing for the best overall result. All participants were given access to similar computers provided for the study and all search activities were performed at the same location. Communication between the different teams was not permitted. This format, called a "science hackathon" (Scithon) by IRIS.AI, was originally applied in the IT industry ("hackathon") with the goal of finding a solution to a programming challenge. Currently, this format has been adapted for the application in multiple fields including scientific purposes as well as general topics such as e. g. marketing."
