Sample size	A sample size of 16 was included (3 for each type of plastic (4) and control, plus one for the initial community). No statistical analyses were used to predetermine this sample size. However, this sample size is large enough for analyses as within each sample 3 aliquots were sampled and homogenized to increase representativeness.
Data exclusions	No data were excluded from the analysis.
Replication	The samples were completed in independent microcosms, confirming reproducibility of results via statistical comparison between treatments. No other replication was completed.
Randomization	Sediment was randomly allocated into microcosms, and sampling aliquots were collected randomly in each sampling time point.
Blinding	Blinding was not necessary for the study as the results were genomic in nature, minimizing the ability for analyst bias.
