Experimental groups were constructed differently depending on the experiment. For example, in the isoform rescue experiments, samples were allocated by treatment (basal, chemLTP) and gene manipulation (shRNA + SynGAP α 1, α 2, β , γ rescue). In other experiments, samples were allocated by biochemical fraction and mouse age. We randomly allocated culture dishes/mice in every set of experimental conditions.
