The n for each experiment is clearly stated in each figure legend. A small number of unreliable, highly-noisy behavioral datasets were excluded from analysis. Criteria for exclusion, which were uniformly applied, were: if worm posture could not be identified in >10% of frames of a video, or if head vs. tail could not be assigned.



Statistical reporting

- Statistical analysis methods should be described and justified
- Raw data should be presented in figures whenever informative to do so (typically when N per group is less than 10)
