## **Additional Details about Methods**

Identifying Beneficiaries with ADRD

The Medicare Master Beneficiary Summary File (MBSF) chronic conditions segment includes beneficiary data for each of the 27 defined Chronic Conditions Warehouse (CCW) chronic conditions. Specifically, we identified AL residents with ADRD as those with a flag for Alzheimer's Disease, Related Disorders, or Senile Dementia. To have this flag, beneficiaries must have at least one inpatient, skilled nursing facility, home health, Part B institutional, or Part B non-institutional (carrier) claim with a related code in any position during the 3-year look-back period.

Identifying a Cohort of Medicare Beneficiaries Residing in AL

We identified Medicare Part B claims in the Carrier File that had a Place of Service code #13 and/or Current Procedural Terminology (CPT) codes 99324-99337, indicating that care was delivered in an AL setting. We used the Outcome and Assessment Information Set (OASIS) to identify beneficiaries with a start of care assessment that had a living arrangement code indicating "congregate living situation with around-the-clock assistance." The Part B Claims/Carrier data and the OASIS were linked to a ZIP code History File (ZHF) to obtain beneficiaries' 9-digit ZIP codes on the claim and/or OASIS assessment date(s) indicating services were rendered in an AL setting. The MBSF was linked to the ZHF to obtain beneficiaries' residential ZIP codes. The ZHF was created by integrating the MBSF and the Enterprise Cross Reference File, which contains beneficiaries' 9-digit ZIP code as of their change of residence date. We then compiled the 9-digit ZIP codes of beneficiaries whose first seven digits of their ZIP codes matched to those of an AL. To that list, we added the 9-digit ZIP codes of ALs and created a yearly finder file of 52,493 validated 9-digit ZIP codes associated with 11,916 ALs (many large AL campuses have more than one 9-digit ZIP code). Using this finder file, we searched beneficiaries' residential ZIP codes to identify Medicare beneficiaries residing in large AL settings with a validated 9-digit ZIP code pertaining to an AL on December 31, 2016.
