Sample size	Sample size was determined empirically to ensure statistical confidence in the results obtained, depending on the expected effect size and our knowledge of the heritability of the trait based essentially on previous experience (Tisné et al., The Plant Journal, 2013; Marchadier et al., PLoS Genetics, 2019)
Data exclusions	no data points were excluded
Replication	All the experiments were replicated at least 2 times to verify the reproducibility with all attempts successful, except the experiments presented in Fig 3 & 4 and Supplementary Fig 4 due to the difficulty and the length of such experiment. This was compensated by a large number of samples
Randomization	Samples were randomized in trays or in the phenotyping robot before measurements.
Blinding	Most of the experiments were done blindingly as the data were collected in a phenotyping platform or numbers were attributed to plant genotypes.
