Sample size	Sample sizes were determined based on similar types of experiments from previously published data sets.
Data exclusions	No data were excluded with exception of whole-cell patch-clamp electrophysiology data. Exclusion of this data was only for cells that were not stable for the duration of the protocol. For example if baseline values became leaky or cells lost gigaohm seals the data was not evaluated.
Replication	For temperature-dependent electrophysiology data, data were recorded on different days from multiple transfections. For heat-activation, the cells were only exposed to heat once, and then the cover slip was discarded.
Randomization	n/a, randomly selected cells were subjected to a TRPV1 specific stimulus, resulting in internally controlled experiments.
Blinding	Blinding was not performed.
