Sample size	2000 simulations were run. These included 175 simulations for the NMDAR augmentation (5 input random seeds x 5 connectivity random seeds x 7 NMDAR scalings), and 1575 simulations for the tri-scaling interactions of NMDAR, Ih, and GABAAR (3 input random seeds x 3 connectivity random seeds x 7 NMDAR scalings x 5 Ih simulations x 5 GABAAR simulations). Additional preliminary simulations to tune the model.

Randomization	We picked different randomization seeds for generating the random input as well as for generating the connectivity.
Blinding	Identical analysis algorithms were used for all simulation results and data was provided directly from these.
