Sample size estimation was not explicitly calculated. Based on prior literature, we estimated that 3-4 participants with coverage of each hemisphere would be sufficient to detect effects. However, we also note that individual electrode effects are sufficient and robust for interpretation.

Number of replicates (electrodes) included in each analysis are identified in line with Results and in accompanying Methods. Whenever data were excluded, detailed rationale is provided in the Methods. Data from two patients were excluded because of excessive epileptiform activity, as described in supplementary Methods (page 19 of revised manuscript). Individual trials were excluded from behavioral analysis if a participant did not make a response or if the participant's reaction time was more than 3 standard deviations from the participant's mean reaction time (page 19 of revised manuscript). Channels with excessive noise in a given experimental block and trial epochs that included time segments with epileptiform activity were excluded (page 20 of revised manuscript). Two outlier electrodes in Figure 3B were identified according to approach explained in Methods (>3 SD from mean; page 23 of revised manuscript). Criteria for exclusion of electrodes during analysis of peaks of the auditory evoked local field potential data are detailed in the Methods (page 27 of revised manuscript).
