We evaluated the performance of our distributed MI methods in simulations and in analysis of the de-identified data from the Georgia Coverdell Acute Stroke Registry (GCASR). Our study did not involve new data collection. Sample size calculations are not applicable. The GCASR data set includes data from multiple hospitals which allow us to mimic a distributed health data network (DHDN) where health data are horizontally partitioned across hospitals and subject-level data cannot be shared or sent to a central data repository. As such, it is sufficient to demonstrate the performance of our proposed distributed MI methods.
