### VERSION 1 – AUTHOR RESPONSE

Abstract: 2nd sentence line 4 to read: Type1 Diabetes presenting with ( not in ) diabetic ketoacidosis.

2nd paragraph: Diabetes is a significant cause ( not risk ) of morbidity and mortality.

4th paragraph: between 1st march 2020 and 30th June 2020.

5th paragraph: The reasons for delayed reporting of presentation were grouped into themes.issues regarding the inability to access GP services as well as limited GP services with no face-to-face reviews, were reported in 22% cases.

NHS11 should read NHS111.Finally 17% cases reported delayed presentation due to symptoms misdiagnosed or not recognised as diabetes such as symptoms mistaken for a respiratory illness during ( not on ) a GP video consultation.

Tiredness due to a lack of routine and increased thirst attributed to a heat-wave by the family.

6th paragraph: The proportion of new-onset T1D in CYP under 18 years presenting in DKA ( 51% ) during this COVID-19 period was higher than the previously reported 38% in the UK around the aforementioned period.

In comparison ( While not needed in the beginning of sentence ).

Reference 3 from Germany was published in 2003 : need a recent reference

Reasons for delayed presentation ranged from fear of contracting COVID-19 to inability to access a medical provider ( it reads to contact access )

Last paragraph : The global epidemiological and clinical patterns of COVID-19 among children are still very limited. Further emphasis should be made on the dissemination of education to healthcare providers regarding the timeliness of referrals of children with T1D.
