Sample size	We determined that sample sizes of 2-6 technical replicates for synthetic target experiments was sufficient because the variation across replicates is small. No statistical methods were used to predetermine sample size. Experiments with patient samples usually contain a single biological and a single technical replicate per sample due to sample volume constraints and the inability to obtain biological replicates. When volume was available, patient sample experiments contained 3 technical replicates.
Data exclusions	Data were not excluded from any analyses.
Replication	Experiments were performed independently. Experiments with synthetic targets were replicated 2-4 times total, and all replication attempts were successful. Due to sample volume limitations, experiments with patient sample testing were only performed once.
Randomization	Randomization was not necessary as we do not run experiments in which we directly compare patient samples across two or more conditions (e.g., different testing strategies or regimes).
Blinding	Blinding was not necessary as we do not run experiments in which we directly compare patient samples across two or more conditions (e.g., different testing strategies or regimes).
