Sample size	We used individual level data from 10,708 participants of the Fenland cohort with available genotype and proteomic data.
Data exclusions	We excluded 1727 participants with missing genotype data.
Replication	We replicated a subset of 125 genetic variant-protein associations using the complementary Olink technology in a subset of 485 participants, in which 36 (30%) associated at least at nominal significance.
Randomization	All genetic associations were controlled for age, sex, test site, and population stratification.
Blinding	Blinding does not apply as information on genotype and protein levels was needed to perform analysis.

Population characteristics	Fenland participants were on average 48.6 years old (standard deviation: 7.5 years) and 53.4% were female.
Recruitment	Fenland is a population-based cohort study of 12,435 participants without diabetes born between 1950 and 1975. A detailed description can be found in the Methods section.
Ethics oversight	The study was approved by the Cambridge Local Research Ethics Committee (NRES Committee – East of England Cambridge Central, ref. 04/Q0108/19) and all participants provided written informed consent.
