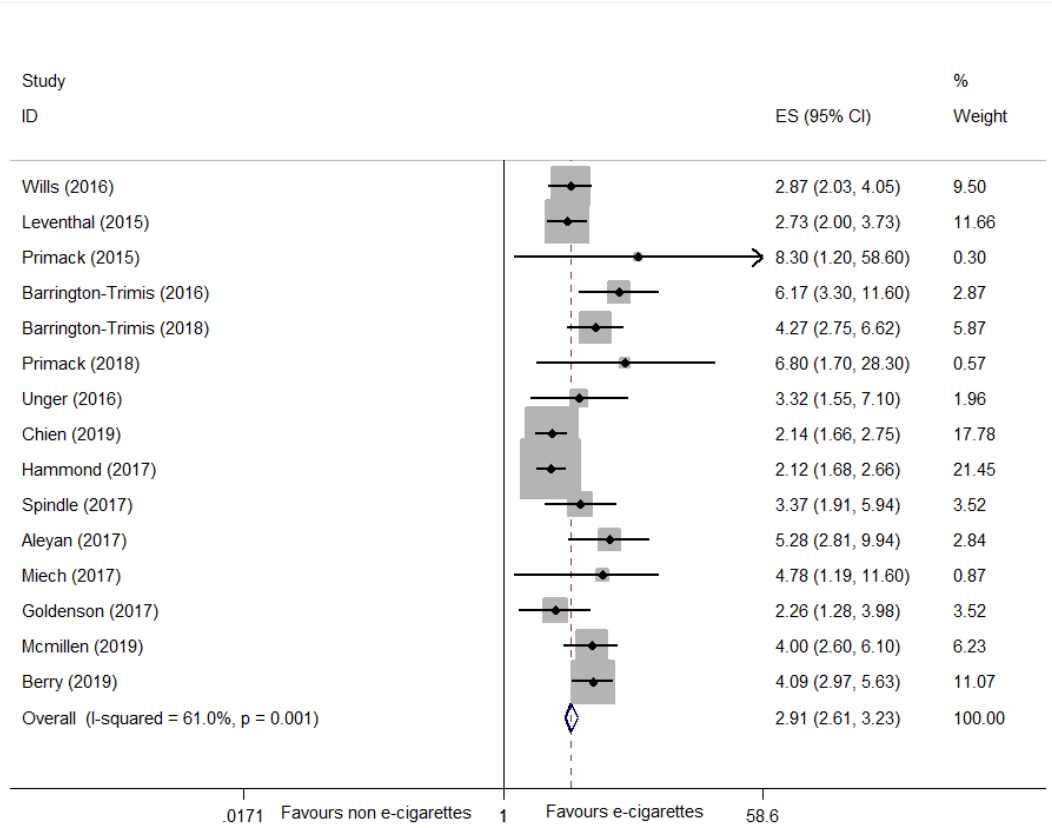


Figure S1. Meta-analysis of cohort studies comparing ever e-cigarette use with non-use on smoking initiation

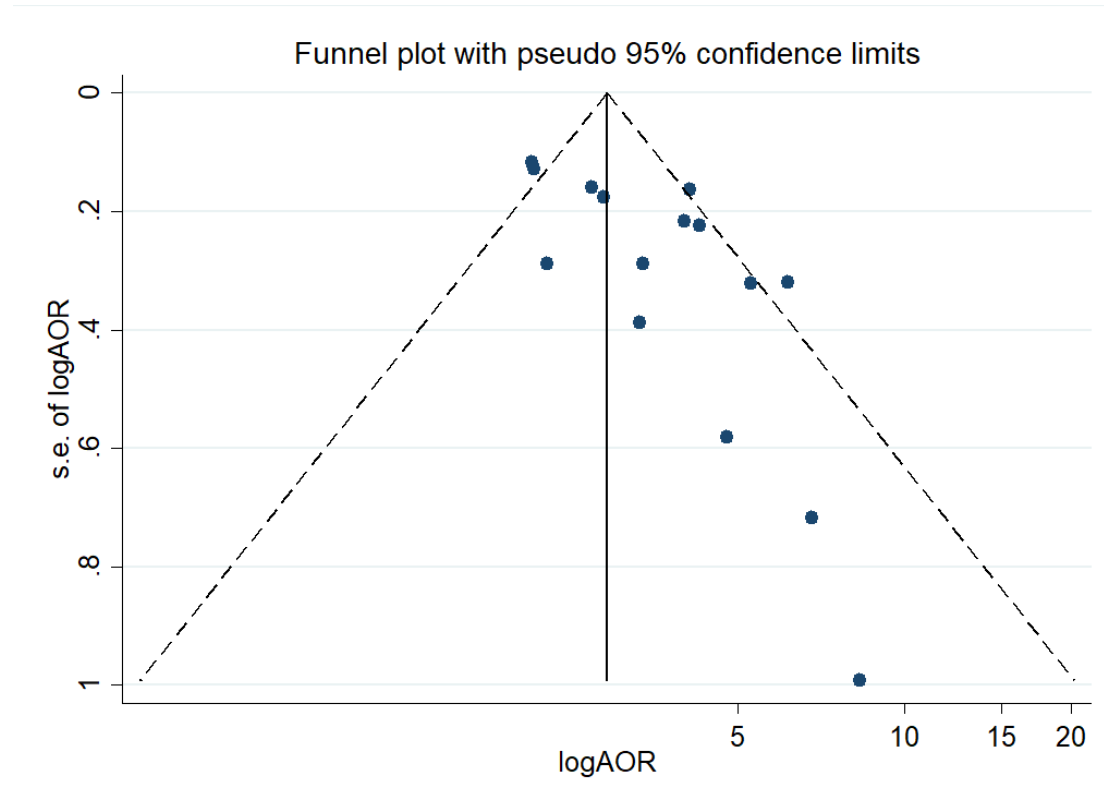


Figure S2. Funnel plot of smoking initiation comparing ever e-cigarette use with non-use among adolescents
