The nucleotide sequences of the SARS-CoV, Bat-SL-RATG13, Bat-SL-CoVZC45, and Bat-SL-BM48-31 are downloaded from the GenBank (<https://www.ncbi.nlm.nih.gov/genbank/>).

The multiple sequence alignment is carried out by using an online server Clustal Omega (<https://www.ebi.ac.uk/Tools/msa/clustalo/>). The figure of 3D protein structures are generated by an open source software PyMol (<https://github.com/schrodinger/pymol-open-source/>). The visualization of proteoforms are created by an online server Protter (<http://wlab.ethz.ch/protter/start/>).
