Biological replicates were done using independent cell preparations, either new vials were used or consequent cell passage. Experiments in which cells were differentiated and treated with compounds were conducted independently for each biological replicate. When used for WB, samples were treated and collected on different days and processed at the same time. WGA and laminin assay experiments were performed at least twice using samples treated and collected on different days. The number of biological replicates for each experiment is reported in the respective figure legend. No outliers have been excluded from the data
