While we did not explicitly perform a sample size calculation, we used a sample size consistent with previous similar studies which have been powerful enough to show relevant effects. We conducted a power analysis as part of our statistics.

Inclusion criteria of the participants are described in the "Participants" subsection of the Methods. Each participant is a biological replicate. Numbers of subjects included in the analysis are given in the Figures.
