## Notes:

- 1. Rehm et al. included in their list six additional health conditions wholly attributable to alcohol: foetal alcohol syndrome(Q86.0), foetus and newborn affected by maternal use of alcohol (P04.3), maternal care for (suspected) damage to foetus from alcohol (O.35.4), excess blood alcohol (R78.0), toxic effect of alcohol (T51), evidence of alcohol involvement determined by blood alcohol level (Y90). In our analysis these six conditions were excluded.
- 2. Data on alcohol-induced pseudo-Cushing's syndrome (E24.4) for both men and women, and on alcoholic myopathy for women were not available in Polish mortality database.
