Agilent Cary-5 spectrophotometer; Hitachi F-7000 fluorescence spectrometer; JEOL JEM-200CX transmission electron microscope (TEM); Malvern Zetasizer Nano ZS

Data analysis

UV-vis spectra were recorded via an Agilent Cary-5 spectrophotometer. Steady-state fluorescence spectra were measured with a Hitachi F-7000 fluorescence spectrometer. The morphology of the TTA-UC nanoparticle was characterized by using a JEOL JEM-200CX transmission electron microscope (TEM) operated at 80 kv. The sample for TEM measurement was prepared by dropping the solution onto a carbon-coated copper grid after negative staining with 10.0% (w/v) sodium phosphotungstic acid. The particle size and size distribution of the TTA-UCNP in aqueous solution was measured by using dynamic light scattering (DLS) via a Malvern Zetasizer Nano ZS. All statistical analyses were performed on Origin 8.5
