The sample size for each experiment is provided in the relevant figure legends. Power analyses were not performed prior to the beginning of the study; however, sample sizes were estimated based on similar studies performed at the Orentreich Foundation for the Advancement of Science, assessing the effect of methionine restriction on dietinduced obesity, glucose metabolism, and the levels of circulating hormones in C57BL/6J mice (e.g., Ables et al., 2012, PLoS One, 7:e51357; Malloy et al., 2012, Metabolism, 62:1651-61). In such studies, power analyses using a two-sided test and a 5% significance level revealed that 8 mice per condition was sufficient to provide a power/confidence interval of greater than 99%. Experiments using smaller sample sizes were confirmatory.
