- Methods-only References

Please do **not** embed figures in word files (See Figure Formatting Guidelines below). Large tables that cannot be comfortably incorporated into the manuscript text may be submitted as Supplementary Tables if necessary.

Author List and Affiliations

Please arrange your cover page so the information appears in the following order:

- Title
- Author List
- Institutions
- Present addresses
- Equal contributions statement
- Corresponding author statement.

Please ensure that you have approved your final author list as requested above.

ORCID information. - Panel labels are placed on top of images
- If chemical structures appear within the main figures or the Graphical Abstract, please upload original ChemDraw (CDX) files in addition to figure files
