No explicit power analysis was used, but we built on the power analysis of an MEG study that analyzed the same neural system (Allen et al., 2018, see references and Discussion section). Since we also aimed to correlate brain activity to a behavioral measure (stop signal reaction time), we conservatively increased the sample size by factor three.
