For the computational studies, analysis of the convergence of lipid sampling is provided in the Figure 1 - figure supplement 1, and Figure 6 - figure supplement 1. In addition, details of this analysis are in the results and methods section.

For the experimental studies, at least 3 independent sample replicates were carried out except where otherwise noted. No other statistical method was used to estimate necessary sample sizes.
