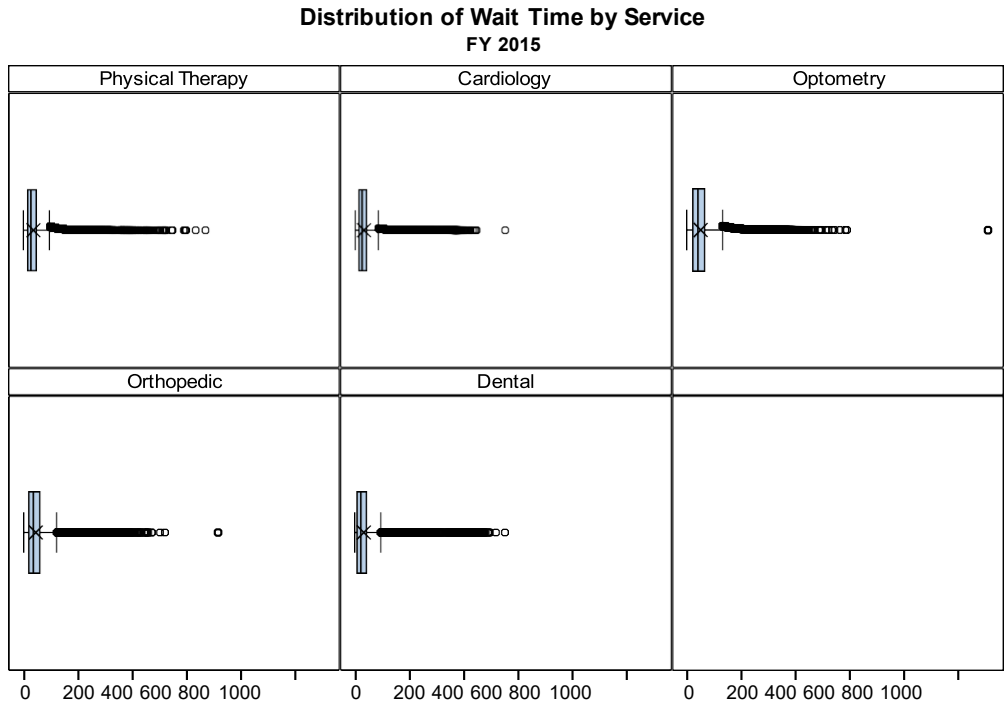
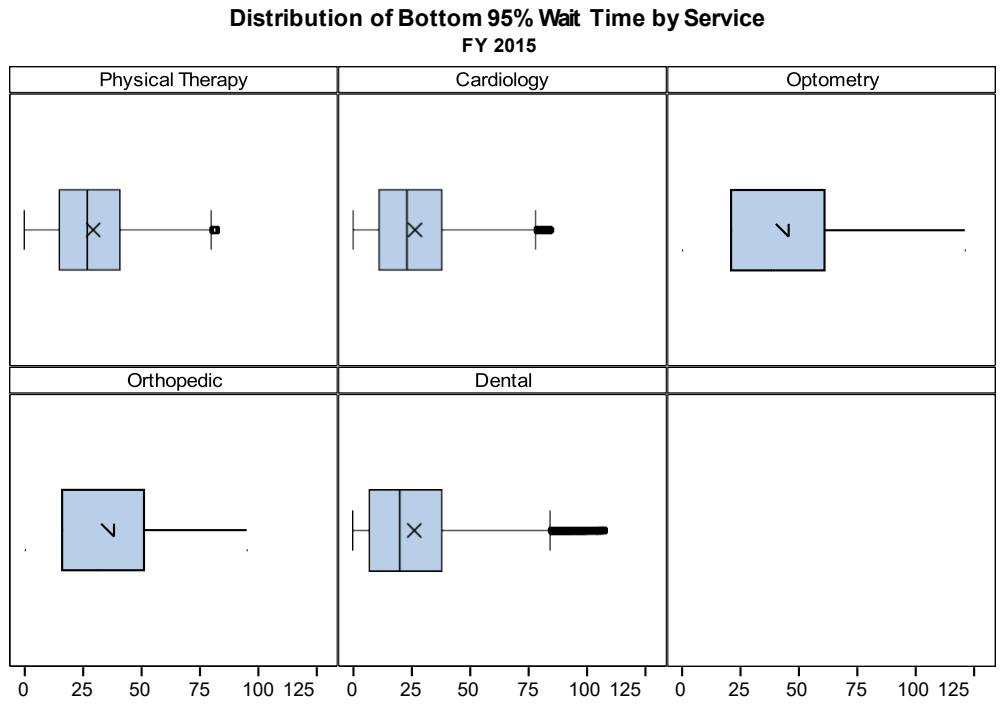


Figure 1. Box Plots
