



Supplementary Figure 1: Significant concordance between clinical DNA-based NGS panels used in the LEAP Consortium study. Graph shows each mutation with associated VAF using the trial panel (x-axis) compared to institutional panel where available (y-axis). Open circles show where frameshift mutations had different alignment between laboratories but with similar effect of the mutation on the protein.
