Such was chosen based on experience and knowledge on expected biological variability (which cannot be controlled by the experimenter) and accuracy of the experimental methods used. we used 3 independent biological experiment that were performed in 3 technical replicates. 3 independent experiments are very common in biological samples (DOI: 10.1021/acssynbio.9b00075; 10.1371/journal.pone.0238993; 10.1371/journal.pgen.1006474; 10.1016/j.cub.2016.01.032; 10.1111/1751-7915.12258; 10.1186/s12934-015-0341-2; 10.3390/microorganisms8081131) |
| Data exclusions | No data were excluded from the analyses.   |
| Replication     | All attempts at experiments replications were successful. Experiments were performed 3 times in independent biological experiments in 3 technical replicates.  |

Comparisons were not performed on individual organisms (with high level of individual variability) but on large populations of microbes that were independently initiated from small number of cells.
