A biological replicate represents an experiment performed on a specific day. Plaque, egress and invasion assays were repeated a minimum of three independent times. Each fluorometric experiments was repeated a minimum of three times with a different set of parasites. For each experiment, two technical replicates were done. Technical replicates are experiments performed in the same day. For the electrophysiological analysis three biological replicates were done and for each biological replicate three different cells with 5 technical replicates per cell were performed. The information is described in the figure legends and the Experimental Methods section. The immunoprecipitation assay was repeated three independent times and two of those samples were analyzed by mass spec.

Statistical reporting

The statistical test used through the study was the Student's t -test. n was equal to the number of biological experiments. Error bars in each bar graphs represent the standard error of the mean. The information is described in figures legends as well as the methodology section.
