Extraction of axon/bouton signals in 2-photon imaging experiments was performed with custom functions that are available upon request to, and will be fulfilled by, the lead contact (michael.lohse@dpag.ox.ac.uk). For extraction and preprocessing of cell body 2-photon calcium signals, we used suite2p (<https://github.com/MouseLand/suite2p>), which performs spike deconvolution based on the OASIS algorithm (Friedrich et al., 2017, PLOS Comput. Biol. 13(3):e1005423).

Data exclusions	For estimation of somatosensory modulation of noise responses, we only included units/boutons that showed a statistically significant response during sensory stimulation compared to baseline (t-test, $p < 0.005$ ). For estimation of somatosensory modulation of tone responses, we only included units/boutons/cells that showed a statistically significant difference in response among frequency-level combinations (one-way ANOVA, $p < 0.005$ ).
Replication	All experiments were performed in multiple animals (see text for details of numbers of animals and neurons) with consistent outcomes in each case. Each experimental procedure (virus injections, electrophysiological recordings, 2-photon imaging and optogenetic manipulations) was performed by a specific researcher to ensure that consistent procedures were followed every time. In all cases, histological verification was performed at the end of the experiment to confirm location of injection and recording sites.
Randomization	Animals were randomly selected for experiments by animal care staff without knowledge of the experiments. In every analysis, all non-excluded neurons from all animals were assigned to all conditions, so no random assignment was required.
Blinding	All animals contributed to all conditions for the experiment they participated in, so there was no group allocation at this stage. Pre-processing of data (i.e. spike sorting, cell/axon identification in 2-photon imaging experiments) was performed blind to experimental conditions. Virus injections, electrophysiological recordings, 2-photon imaging and optogenetic stimulation all required targeted injections and electrode placement in or light delivery over specific brain regions, precluding any blinding. The researcher assisting with the histology was blind to groups and experimental details. All data were analyzed using the same code to ensure that there was no bias.
