No sample size was pre-computed. Sample sizes for infection were based on previous studies of *M. tuberculosis* and *L. pneumophila*. We used a minimum number of replicates (n of 2) for RNA-seq and amplicon sequencing experiments. Sample sizes for RT-qPCR experiments were coordinated with numbers of animals used in infection and approximated from previous studies.
