## Life sciences study design

Sample size	Sample size can be either defined as single particle/trajectory numbers or number of independent repeats of the same experiment. Particle numbers were very high for individual experiments and provided statistics to clearly determine molecule population behaviour. To show that this population behaviour was reproducible, 3 independent repeats of each experiment were considered sufficient, since deviations between repeats were low.
Data exclusions	No data was excluded.
Replication	Three independent experiments for all measurements. All replicates were used since none deviated significantly.
Randomization	Not applicable. No clinical trials involved. Single molecules provide intrinsically randomised data because their properties are unknown prior to their analysis and no data was excluded.
Blinding	Blinding was not required, since no data was excluded and the analysis routines were completely automated. Hence, analysis was intrinsically without user-bias.
