Population characteristics	Eight volunteers enrolled in a Phase 1 study of a single-dose regimen of a gorilla adenovirus vectored vaccine (GRAd-COV2). These subjects, outside the study procedures and in the context of the Italian National Vaccination Campaign (Table 1), received either a full course (n=3) or only the first dose of BNT162b2-mRNA (n=3), or one dose of ChAdOx1 (n=2). The subjects were all male by chance (even if the original trial enrolled volunteers of both sexes), and with ages ranging between 21 and 80.
Recruitment	It was an autonomous decision of the eight subjects to enter National COVID-19 campaign before the end of the clinical trial follow up
Ethics oversight	Italian National Ethical Committee for COVID-19 clinical studies
