Sample size	A total of 11588 cryo-electron microscopy movies were collected from the OMCC sample, and an initial set of 1445958 particles were processed (see Table 1 for details). Sample sizes were those required for the resolution.
Data exclusions	Final map was obtained upon standard 2D and 3D classification approaches were used in CryoSPARC to exclude data.
Replication	Two randomly divided half datasets were processed independently, and combined to obtain the final 3D map. Resolution was assessed by comparing two independent mmaps.
Randomization	Data collection was randomly set by the EPU software. CryoEM particles were randomly divided into two groups as a standard approach.
Blinding	cryoEM dataset was blindly collected.
