Replication	Independent isolates with the same genotype were used to verify experimental findings. All attempts at replication were successful
Randomization	All mutants used for the recombination assay were treated equally
Blinding	Blinding is not relevant to the study because all mutant strains were compared to wild type. To avoid any bias, labels of plates were concealed until all the colonies had been counted.
