Sample size	Sample sizes are similar to those used in other primate studies (Steinmetz and Moore, Neuron, 83, 496–506, 2014; Nandy and Reynolds, Neuron, 93, 235–246, 2017). The number of trials in each session was determined by the animals' ability to perform the task. The number of simultaneously recorded neurons was determined by the characteristics of the multielectrode arrays. The number of subjects (2) is standard for the primate studies.

Replication	All of analysis results were successfully replicated in two macaque monkeys.
Randomization	Participants were not allocated into groups. No subject randomization was implemented
Blinding	Blinding is not relevant. Two macaque monkeys were used. There were no differences between the subjects that would conceivably create biases.
