Sample sizes are taken from previous literature and are in line with estimates derived from previous experiments, using G\*Power Version 3.1.9.6. Specifically, for behavioral experiments using optogenetic and shRNA sample size was in the range of 6-10 animals (effect size 0.45, (Groessl et al., 2018)). Establishing of the behavioral assay, neural recordings, optogenetic and pharmacological manipulation were performed in independent experiments, with separate animal cohorts, where applicable. Basic behavior was replicated across experiments for control groups. Optogenetic manipulations were replicated on separate experiments and cohorts. Neural activity recordings were replicated in independent animals (biological replicates), and across sessions within animals. For behavioral experiments, animals were excluded for low virus expression, misplaced/broken fibers or technical issues with the equipment. Statistical outliers were excluded by using the Grubbs's test. The statement and details animal numbers in this regard can be found in the Methods section 'Data Exclusion'.



### Statistical reporting
