No explicit power analysis was used. We used fifteen human participants in this study. Human behavioural studies on this topic typically use a sample size of less than ten.

The experiment was performed once on each participant, so technically data from each participant is a biological replicate of the human brain which gives us a total of fifteen independent biological replicates. Data from all fifteen participants are included in the study. No outliers.

The study used a single group of healthy participants so there was no need. Randomization was performed independently for both key variables (sensory modality and time constant of motion dynamics) across trials for each participant.
