Sample size information can be found in the methods section. All available samples were profiled for each cohort. Because data was lacking to support reliable sample-size estimations, multiple cohorts were employed in order to validate observations.

### Replicates

Replicates are described in figure legends (e.g. Figure 5C). Replicate/validation cohorts are described in Table 1 and presented throughout main text and supplemental figures.



### Statistical reporting
