In this study, no explicit power analysis was used. We derived our conclusion mainly from three gREST_SSCR and classical MD simulations. The reliability of the conclusion was assessed by extensive free-energy and structural analyses in comparison to Cryo-EM structures. The information of the simulations is listed in Table 1.

We confirmed that our simulation observe structural transition of the receptor binding domain (RBD) in all three simulations. Even within the same simulation multiple replica undergo similar transition as can be seen form the changes in hinge angle and root mean square deviation (RMSD) in the supplementary figure 4.
