Replication	The reproducibility of the experiment was verified in two way: 1) the exact same results were replicate when the code was run with fixed random seeds in Python or R; 2) the results were very similar and conclusion remained the same when the code was run with varying random seeds in Python or R.
Randomization	The assignment of samples to training or validation group is done by random sampling in Python or R. No covariate analysis was done.
Blinding	Authors were blinded to the assignment of samples as it is done by random sampling.
