Replicate numbers were not determined in advance. The number of biological repeats were determined based on previous experience with the techniques. For each biological repeat of flow cytometry, 10,000 events were collected and analyzed. For each immunofluorescence experiment, the number of cells analyzed in the quantification are indicated in the figure legends.
