Integration with prior work, implications, transferability, and contribution(s) to the field - Short summary of main findings; explanation of how findings and conclusions connect to, support, elaborate on, or challenge conclusions of earlier scholarship; discussion of scope of application/generalizability; identification of unique contribution(s) to scholarship in a discipline or field	Pages 19-20
Limitations - Trustworthiness and limitations of findings	Page 22

Conflicts of interest - Potential sources of influence or perceived influence on study conduct and conclusions; how these were managed	Page 23
Funding - Sources of funding and other support; role of funders in data collection, interpretation, and reporting	Page 22

The SRQR aims to improve the transparency of all aspects of qualitative research by providing clear standards for reporting qualitative research.
