**ad hoc** patient-reported outcome measure. Patient-reported outcome measure with unavailable details regarding development and measurement properties.

**affinity diagram.** Bottom-up data organization intended to define categories based on likeness of data.<sup>1</sup>

**concept.** The specific measurement goal (*i.e.*, the *thing* that is to be measured by a patient-reported outcome measure).<sup>2</sup>

**generic patient-reported outcome measure.** Patient-reported outcome measure that is applicable to a wide range of health conditions and treatments.<sup>3</sup>

**item.** An individual question or statement (and its standardized response options) that is evaluated by the patient to address the concept.<sup>2</sup>

**measurement properties.** Nine different aspects of reliability, validity, and responsiveness of a patient-reported outcome measure that together represent the measure's quality.<sup>4</sup>

**patient-reported outcome.** Report of the status of a patient's health condition (*e.g.*, quality of life, symptoms, treatment effects, functioning) elicited directly from the patient, without interpretation of the patient's response by a clinician or anyone else.<sup>2</sup>

**patient-reported outcome measure.** Tool (mostly questionnaires and surveys) used to measure a patient-reported outcome<sup>3</sup>: a report of the status of a patient's health condition (*e.g.*, quality of life, symptoms, treatment effects, functioning) elicited directly from the patient, without interpretation by a clinician or anyone else.<sup>2</sup>

**sensory modality.** An aspect of a stimulus or what is perceived after a stimulus. The basic sensory modalities include: light, sound, taste, temperature, pressure, and smell.<sup>5</sup>
