Details of number of experiments (number of mice, number of neurons etc) are reported in the Materials & Methods section as well as throughout the paper where numbers are reported for results. Any cases where imaging data was excluded due to anatomical mislocalization of the lens, insufficient calcium transients, or trials were excluded are described in the Methods section with the criteria stated.



### Statistical reporting
