Sample size	For the animal studies at least 3 and up to 7 animals per group and time point/ analyses were used - the sample sizes are detailed in the manuscript. The study is mostly descriptive in nature, therefore sample size calculation was not performed. Only the analyses for the size of fatty vacuoles of adipocytes has been statistically evaluated here n=100.
Data exclusions	Due to the descriptive nature of the data we did not exclude any data points.
Replication	Replication was done only with respect to the repetition of the surgery within the respective groups: amputation, fixation and non-fixed osteotomies.
Randomization	Animals were randomly allocated to the different groups.
Blinding	Blinding was not possible because the data clearly shows the treatment that has been applied.
