

# Feedback Report on the CLC Partnership and Documented Life-Sustaining Treatment Decisions in the CLC

The following pages present data about the number of completed LST templates for Veterans at the VAMC.

Please review these charts to encourage reflection on your current practice and how VAMC might increase the number of goals of care conversations (GoCCs) and completed LST order templates.

To better understand the data, please keep in mind these points:

- Data are collected monthly.
- Data are displayed for all Veterans residing in your CLC, including those Veterans diagnosed with dementia, month by month.
- Veterans are defined as either long stay or short stay residents, based on their earliest treating specialty at admission in a given month; those admitted for hospice are counted as long stay residents
- Data comes from the LST template in CPRS. Only templates with answers for all 4 required questions were counted.
- If a Veteran had more than one LST template completed in a month, only the first template was counted.
- Each Veteran was counted only once even if they had multiple stays.


