II. Details about non-U.S. datasets

All surveys were conducted between July 30–August 24, 2020 using an online interview administered to members of panels that YouGov constructed and maintain. Emails are sent to panelists selected at random from the base sample. The responding sample is then weighted on age, gender, and region to reflect the composition of each country's population using available census data. The survey was originally written in English and translated into the other languages by either the YouGov offices in those countries or certified partners.






IX. Are conspiracy theories for political extremists?

Though tangential to our central theoretical concern in the manuscript, some argue that conspiracy theories are found not among the political left or right, but the most extreme partisans and ideologues regardless of party or ideology (van Prooijen et al., 2015). We examined this proposition across the 18 surveys used in Finding 3 (Figure 4). First, we regressed the ACTS on partisan and ideological identities for each survey. Then, we re-estimated these models, including quadratic partisanship and ideology terms (i.e., squared versions, which are the most straightforward parametric way to estimate simple nonlinearities of the type offered by the extremity thesis). Next, we compared the second model to the first using a nested model F-test. If the comparison is statistically significant—and the quadrative terms are positive (indicating higher levels of conspiracy thinking among the extremes)—we will have evidence for the extremity thesis.

Results are quite mixed. In only 5 surveys—Lucid April 2020, Qualtrics March 2020, Lucid January 2020, Qualtrics March 2019, and Lucid September 2019—did we find that the quadratic model was significantly better (p<0.05) than the simple additive model and that the coefficients on the quadratic terms were in the correct direction (i.e., positive). In 4 surveys—Qualtrics May 2021, Qualtrics February 2020, CCES 2018 (2), and SSI July 2016—we observed a significantly better fit for the quadratic model, but opposite directions on the partisanship and ideology quadratic terms (i.e., one positive, one negative). On 2 surveys—NORC November 2019 and CCES 2016 (2)—we found a significantly better quadratic model fit with only negative quadratic terms, the opposite of what the extremity theory posits. Finally, in 7 of the 18 surveys—Qualtrics October 2020, Qualtrics June 2020, Qualtrics July 2019, CCES 2018 (3), CCES 2018 (1), CCES 2016 (1), and CCES 2012—we found no significant improvement on the quadratic model over the simple additive model.

In short, we possess mixed evidence, at best, for the extremity thesis. We reiterate that this is not the focus of our paper. Still, this analysis was useful for ensuring that the correlations we computed in the main text were not masking some other type of systematic structure in the data. We provide examples of the bivariate relationships between conspiracy thinking and political orientations from the two most recent surveys in Figure A3 below.
