## Life sciences study design

Sample size	We made use of the largest publicly available whole-genome sequencing data set at the time of study, representing 71,702 individuals. The sample size was outside the control of this study.
Data exclusions	CpG sites were excluded from gnomAD v3 owing to their atypical mutation rates and patterns. Smaller classes of noncoding RNAs from GENCODE were excluded from certain analyses, as detailed in the text.
Replication	This study is a statistical analysis of an extremely large, one-of-a-kind public data set, so it does not address replication per se, but we did rigorously assess the statistical uncertainty associated with all estimated quantities. We also extensively validated our mutation model, by a variety of different means (detailed in the paper).
Randomization	The subjects were analyzed in one group so no randomization was needed.
