- 4. This approval is valid for entire duration of the study (i.e. **01 year**). The review application must be submitted to the IEC-AIIMS Raipur in order to continue the study beyond the approved period.
- 5. All the co-investigators must be kept informed of the status of the project.
- 6. Changes, amendments, and addendum to the protocol or the consent form, must be submitted to the IEC-AIIMS Raipur for re-review and approval prior to the activation of the changes.
- 7. Any change of study site, change of investigator/s, termination of study (with reason to do so) should also be informed to IEC-AIIMS Raipur.
- 8. The IEC proposal number assigned to the project should be cited in any correspondence.
- 9. Any Serious Adverse Event (SAE) occurring during the course of the study should be reported to the IEC-AIIMS Raipur.
- 10. New information that becomes available which could change the risk: benefit ratio must be submitted promptly for IEC review.
- 11. Only approved consent forms are to be used in the enrolment of participants. All consent forms signed by subjects and/or witnesses should be retained on file. The
