eMethods. Survey Development Information

Throughout the development of the survey, members of the study team sought feedback from a convenience sample including undergraduate students. These individuals were asked to complete the survey multiple times to report on its comprehensibility (e.g., did they understand the questions) and mechanics (e.g., technical errors in the coding of the survey), as well as any omissions or redundancies in the survey.

We had several mechanisms in place through Qualtrics to prevent the survey from being completed by bots/survey screening programs. First, we prevented multiple submissions so participants could not take the survey multiple times. Second, we used Google's invisible reCaptcha as a bot detection technology; all participants included in the final sample had a reCaptcha score greater than .6 (A score of greater than or equal to 0.5 means the participants is likely a human. A score of less than 0.5 means the participants is likely a bot.). Third, we also enabled security scan monitor which prevents email security scanning software from accidently starting surveys. Fourth, we blocked search engines from including our survey in their search results limiting access only to those who had been invited.
