Number of replicates is indicated in both the text and figure legends. For behavioural experiments, each data point within every figure represents a different mouse (biological replicate). For receptor autoradiography experiments, the number of biological replicates is indicated in the figure and table legend. For heart histological determinations the number of technical and biological replicates is identified in the figure legend. For immunoblot, two technical replicates were performed in parallel. The average of the technical replicates was used as a measure. Biological replicates for these determinations are identified in the figure legends. As specified in the methodology, outliers (± 2 Standard Deviation from the mean) were excluded from the study. RNAseq data is uploaded in GEO (GSE164257).

Statistical reporting
